#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

The buyer organization is an institution eligible for concessional rates of GST as notified by the Government of India. The services for which bids have been invited fall under classification of GST concession and the conditions for eligibility of concession are met by the institution. A certificate to this effect will be issued by Buyer to the Seller after award of the Contract. Sellers are requested to submit their bids after accounting for the Concessional rate of GST.

#### 3. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 5. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

# 6. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

The duty of "Security Guard" shall be giving security in the Office building and its complex and Reside ntial complex. Duty hour will be 24 (twenty four) hours daily as provided in Rule 24 of Minimum W ages (Central) Rules, 1950. Necessary tools and equipments shall be provided by the Purchaser.

The deployed of "Security Guard" shall be required to work 24 (twenty four) hours daily on all days as provided in Rule 24 of Minimum Wages (Central) Rules, 1950. They shall be stationed at the Office Building and in the residential complex. The person (s) deployed by the Service Provider will be provided an semi-furnished accommodation where the Security personnel can stay as and when the off duty hours in the rotational basis. They will be entitled for remuneration/wages/pay f or such weekly days of rest and rest gazetted holidays in the same manner as on a working day. T

he same shall be governed by the Code on Wages (Central) Rules, 2022 as and when it comes int o effect in pursuance of Code on Wages, 2022.

#### 7. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 8. Buyer Added Bid Specific ATC

## Preference in respect of bidder:

Out of all bidders who fulfill eligibility criteria as above, preference shall be given to the Bidder who has past experience of supplying manpower to any office of the Income Tax Department and is established **locally i.e., in Jorhat.** Next preference shall be given to the Service Provider who has past experience of supplying man power to any other office of the Central or State Government subject to meeting of all other prescribed criteria. For this purpose, decision of the Purchaser or Competent Officer of the Purchaser shall be final.

Preference shall be given to the person(s) who have past experience of working in any office of the Income Tax Department. Next preference shall be given to perso n(s) who have past experience of working in any other office of the Central Government or the State Government. Decision of the Purchaser shall be final in this matter.

**Increase and decrease of number of persons:** The Purchaser may increase or decrease the number of persons supplied for performance of outsourced services at any time depending upon the work in the office of the Purchaser and the service provider shall be bound to increase or decrease the number of persons supplied for performance of outsourced services on receipt of such a request from the Purchaser.

**Extension of agreement:** The contract/agreement is extendable for 1 (one) mor e year, i.e., up to 30.06.2025, at the sole discretion of Purchaser subject to policy guidelines of the Department and satisfactory performance of the Service Provider and, if required, with such amendments/modifications of terms and conditions as may be mutually agreed to including rise in wages/service charges taking into acc ount the increase in minimum wages by the Government of India after the contract comes into force.

**Revision of contract and wage rates:** The contract between the Purchaser and the Service Provider shall stand revised to the extent of rate of wages payable as and when minimum wages are revised by the Central Government.

### 9. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

The Service Provider is required to have at least 40 % of the required manpower on service provider's payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
