TERMS AND CONDITIONS:

- A. The bidders shall bear all costs associated with the preparation and submissions of their bid. The Joint Commissioner of Income-tax, Assessment Unit-1(3), Dibrugarh (Station Tinsukia) will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- B. The prospective bidders shall be required to visit the site where the works are required to be undertaken at their own cost during office hours to ascertain the requirements of expenditure to be involved in the completion of works.
- C. The bidders shall quote rates for the proposed works in the prescribed proforma.
- D. The contractor shall submit the Technical and Financial Bid separately. The Financial Bid shall be required to be placed in a separate sealed cover.
- E. The rate quoted shall be inclusive of all taxes, including labour and other miscellaneous costs etc.
- F. The selected contractor should be in a position to complete the work withing 30 (Thirty) days of awarding the contract.
- G. **Escalation**: No escalation of any of the items or statutory levies will be entertained. Prices shall be fixed till the end of the contract.
- H. The works shall be carried out under the direction and supervision of this office.
- I.
