<u>AUCTION NOTICE FOR E-WASTE DISPOSAL</u> Dated: Guwahati, the 1**6**th October, 2025

This is to notify for general information that this Office is going to dispose of electronic scrap (e-Waste) through auction, to be held at the Multipurpose Hall, 9th Floor, Aayakar Bhawan, G.S. Road, Christianbasti, Guwahati – 781 005 on 24/10/2025 at 03:00 pm.

The terms & Conditions of the aforesaid auction shall be as under:-

- 1. The e-Waste offered for auction shall be sold/auctioned on "AS IS WHERE IS BASIS".
- 2. The e-Waste items are stored at the Multipurpose Hall, 9th Floor, Aayakar Bhawan, G.S. Road, Christianbasti, Guwahati 781 005 and the same can be inspected on any working day from the issue of this notice from 03:00 pm to 04:00 pm.
- 3. Auction will be held as per Departmental Rules and Regulations. No Government transportation will be provided to lift the auctioned e-Waste.
- 4. Interested parties/bidders may participate in auction. However, bidders having GST, PAN Card and E-Waste Authorization from State/Central Government will only be allowed to participate in the auction. The bidders shall have to fill-up all the annexures accordingly to apply for the auction.
- 5. The bidder which offers the highest total rate for the entire lot of e-Waste as detailed in Annexure-IV and whose bid has been determined to be eligible and responsive, will be determined as the successful bidder.
- 6. The decision of the Presiding Officer conducting the auction shall be final in all matters relating to the auction. However, all or any bid can be rejected by the Principal Chief Commissioner of Income Tax, NER, Guwahati, without assigning any reason.
- 7. Time allowed for lifting of scrap is 07 (seven) days from sale by auction.
- 8. The e-Waste items are required to be disposed of in an eco-friendly manner following the relevant guidelines of the Government of India and the State Government.
- 9. If the Government declares a Public Holiday on the date fixed for the aforesaid auction, the same shall be held on the immediate next working day at the same time and venue.
